## IMPORTANT TERMS

### AAI IDENTITY (electronic identity)

Upon the enrollment into the first year of studies, each student is given an AAI identity, which they use throughout their studies at the Faculty. The AAI identity is used for accessing Merlin (the e-learning platform), Eduroam wireless network within the Faculty building and other contents intended exclusively for students and Faculty members. A student can get an AAI identity by contacting the Student Registry Office. A student who has forgotten his/ her AAI identity, or his/ her password, should personally contact the Student Registry Office during working hours.

### X- CARD (student identity card)

X-card (student identity card) is a magnetic card containing your photo which can be used for eating government subsidized meals at Student cafeterias and for obtaining other student benefits.

The student card is valid as long as the student is enrolled into the Faculty, and the validity date is extended upon each enrolment into an academic year. If the card is lost or damaged, the student shall request a reissuing of the card for a certain fee.

### MERLIN

Merlin is an e-learning platform based on an open-source system used for conducting classes using the unified AAI@Edu identity which is provided for all members of the academic community.

### JMBAG

JMBAG (Academic Citizen Unique ID Number) – determines each student in a unique manner. The JMBAG is awarded upon the enrollment into a higher education institution. It can be found in the upper left corner of a student's x-card and is made up of three series of numbers.

## TUTORIALS

Tutorials are additional free classes related to a specific course led by a teaching assistant (a senior student who completed the course with excellent success) in agreement with the course leader. These classes are most often held before continuous assessments and exams.

## STUDOMAT

The information system that enables the systematic organization and record-keeping of data for each student. Through Studomat, students can register for and withdraw from exams, access exam schedules, submit requests for certificates, view financial obligations towards the University and Faculty, and access various other student services. Studomat can be accessed via an internet kiosk located on the ground floor of the building or online through designated links. Access requires an AAI identity.

## EFRI APP

The EFRI APP is a mobile application designed for all students of the Faculty of Economics and Business at the University of Rijeka. The application provides information about undergraduate and graduate study programs, including basic details about courses and course instructors. It also includes features such as e-office, class schedule, news, events, implemented QR code scanner, freshmen corner, Faculty contacts, calendar and other study-related information.

## TEACHING EVALUATION

For the continuous improvement of the quality of education, students are given the opportunity towards the end of each semester to anonymously evaluate the teachers who were involved in teaching their courses during that semester. They can also provide suggestions, feedback, and commendation for the teaching processes in the upcoming academic years.



## ECTS POINTS

The European Credit Transfer System (ECTS) is a standardized credit system used in higher education institutions across EU countries. It reflects the student workload throughout their studies, across semesters and specific courses outlined in the curriculum.

Each course is assigned a certain number of ECTS credits, which represent the student workload required for attending that course. This workload includes various activities such as quizzes, seminars, assignments, self-study, reading literature, problem-solving, and exam preparation. The credits are distributed among all courses based on the amount of workload each course demands relative to others in the semester.

ECTS credits also determine the level of student rights that a student can achieve (e.g., health insurance, housing and food subsidies, the level of Ministry support obtained, and the number of courses they can enroll in from higher years of study).

## CONTINUOUS ASSESSMENT/MID-TERM EXAMINATION

Knowledge assessments that test parts of the course material during the semester. In the grading system applied at the Faculty, points earned on colloquia are part of the total points, which, along with other teaching elements, constitute part of the continuous evaluation of learning during the classes (up to a maximum of 70% of the grade points).

## FINAL EXAMINATION

Written and/or oral knowledge assessment at the end of each completed course. Up to 30% of the grade points can be achieved in the final exam.

## LEARNING OUTCOMES

Learning outcomes are statements that describe what a student should know, understand, or be able to do at the end of a course or a specific learning period. They represent the minimum knowledge and competencies that a student must acquire to successfully pass the course.



## CLASS ACTIVITIES

Classes are conducted through lectures, seminars, and exercises, depending on the course plan. Classes are taught by course instructors, their assistants, external collaborators, and guest lecturers.

Through seminar classes, students become more familiar with the topics covered in lectures. To facilitate easier understanding of the material, students are encouraged to create seminar papers, which, depending on the course, may be done in groups or individually and contribute a certain number of grade points.

Additionally, most courses offer DEMONSTRATIONS conducted by students who have passed a particular course with excellent grades. These demonstrations aim to help younger students master the material.

The teaching staff holds CONSULTATIONS weekly. At a specific time, students can visit professors or assistants to review their results on colloquia/exams, request additional explanations related to the material, seminars, and similar topics.

## CONTINUOUS ASSESSMENTS AND EXAMINATIONS

At the introductory lectures, each course holder informs the students about the course, the manner in which the students will be graded (allocation of grade points) within the respective course and course prerequisites. The models of monitoring and assessing student progress as well as other materials and information needed to follow the course (list of readings, tasks, potential seminar topics, changes in schedules etc.) are posted on Merlin and as such, should be checked regularly.

The student may earn a maximum of 70 grade points for successfully completing classwork activities. Grade points are allocated through continuous assessments, seminars, class participation and any other form of evaluation of student progress envisaged by the course curriculum.

The schedule (dates) of written/oral continuous assessments/mid-terms are communicated in advance within the course curriculum published via Merlin.

## WHO CAN TAKE THE FINAL EXAM?

The final examination may be taken by students who have obtained at least 50% of the grade points awarded for class activities (i.e. a minimum of 35 grade points).

In order to pass the course, the student must obtain a minimum of 50% of possible grade points awarded for the final examination (i.e. 15 grade points). A student who has obtained less than 50% of the grade points awarded for the final examination i.e. has not passed the examination on 3 of the 4 possible final examination terms, has failed the course and needs to reenroll it in the following academic year.

The student needs to register (apply) for the final examinations via STUDOMAT. All examination dates as well as deadline dates for registering and withdrawing one's registration are visible on STUDOMAT. A student may sit three times within an academic year for the final examination in each course.

The final grade is the sum of grade points achieved at the final examination and the grade points achieved during classwork. The grading system is as follows:

The Student Union is a student elective representative body that protects students' interests, participates in decision making processes within the Faculty bodies and represents students in the higher education system. ## BIP PROGRAM

Erasmus Blended Intensive Program (BIP) is a short-term educational program that combines online and physical mobility of students and teachers from various European universities. Participants carry out part of the activities remotely (virtually) and part through an intensive stay abroad, usually lasting from 5 to 30 days. The goal of the BIP is to encourage international cooperation, interdisciplinary learning, and skills development through innovative teaching methods.

## ERASMUS

ERASMUS is a mobility program within which students can spend part of their studies at a foreign higher education institution or do an internship program, which significantly contributes to their independence, cultural enrichment, foreign language knowledge and the ability to work in multicultural environment. The Erasmus program allows for students to fulfill a part of their study obligations, including thesis writing, at a higher education institution abroad with which the University of Rijeka has signed an Erasmus Cooperation Agreement. During their studies abroad, the student is exempt from paying tuition fees, while the costs of his/ her stay and travel are partly covered by the Erasmus scholarship. The Erasmus Mobility Call is issued by the University of Rijeka once a year on the University's web pages, for the winter and summer semester, or for the full academic year.

## CEEPUS

CEEPUS is a regional higher education mobility program aimed at enhancing mobility within individual faculty networks. The students participating in CEEPUS are exempt from paying tuition at the foreign institution, and the amount of the CEEPUS scholarship depends on the standard of living in the respective country. Countries participating in CEEPUS are Albania, Austria, Bulgaria, Bosnia and Herzegovina, the Czech Republic, Montenegro, Croatia, Kosovo, Hungary, Macedonia, Moldova, Poland, Romania, Slovakia, Slovenia, and Serbia.
